**RHODE ISLAND DATA/IMAGES SUBSCRIPTION AGREEMENT**

The above-named subscriber (Subscriber) and the Rhode Island Department of State, Business Services Division (Agency), agree to contract for access to Rhode Island Data/Images according to the Terms and Conditions stated below:

1. This Subscription Agreement sets forth the terms and conditions under which the Agency will provide access to the Rhode Island Data/Images specified on the attached Rhode Island Data/Images Subscription Form (Subscription Form).
2. The Agency will provide access to the Rhode Island Data/Images specified on the Subscription Form via a Secure File Transfer Protocol (SFTP). The Subscriber must establish and maintain an SFTP client and a static Internet Protocol (IP) address to access the Rhode Island Data/Images specified on the Subscription Form.
3. The Subscriber shall pay the full subscription amount and setup costs, if applicable, as specified on the Subscription Form.
4. Upon receipt of payment and a completed Subscription Agreement, the Agency will contact Subscriber to set up a user name and password in order to gain access to the SFTP website.
5. This Subscription Agreement is effective for an initial term of one year, commencing upon execution of the Subscription Agreement by the Agency. The Agency will extend the term of the Subscription Agreement upon receipt of a new Subscription Form and payment of the corresponding subscription fees. Either party may terminate this Subscription Agreement by notifying the other party with 30 days written notice. If the Agency terminates this Subscription Agreement, the Agency will refund the Subscriber's money on a pro rata basis based on the remaining time of the yearly contract.
6. The Agency shall not be liable under any circumstances for any damages, including consequential or incidental damages, which may result from inaccurate or erroneous information. The Subscriber agrees to indemnify, defend, and hold harmless the State of Rhode Island, the Agency, and any of its agents and employees from any and all claims and losses accruing or resulting to any and all persons, firms, associations or any other business entities as a direct result of errors or omissions introduced into the data and/or images by the Subscriber and resulting from Subscriber's use and dissemination of any or all of the information supplied to the Subscriber.
7. Any actions arising out of this agreement shall be governed by the laws of the State of Rhode Island and shall be brought in a state or federal court within the State of Rhode Island, which shall have exclusive jurisdiction thereof.
8. This agreement represents the final and complete agreement of the parties, confers no right on third parties, and shall be modified only by a subsequent written instrument signed by all parties. It shall become effective upon its execution by the parties and the agency's receipt of the yearly subscription fee.

In witness to their agreement to the Terms and Conditions above, the Subscriber and the Agency have caused this instrument to be executed by their duly authorized representative.

## RHODE ISLAND DATA/IMAGES SUBSCRIPTION FORM

**Corporate Database (Active)** - Yearly subscription fee - **\$3,000**

*Data is posted on a daily basis.*

The Active Corporate Database consists of those entities of record that are either in good standing, under a 60-day revocation notice or have been revoked for less than one year.

Contents: • Name of Entity • Date of Incorporation • Brief description of business • Name and Address of Registered Agent • Name and Address of Primary Officer, Director or Manager • Business Address • Amendments • Mergers • Fictitious business names associated with the entities • Stock information

**Corporate Database (Active and Inactive)** – Yearly subscription fee - **\$3,600**

*Data is posted on a daily basis.*

In addition to the Active database the Inactive database consists of those entities of record that have been revoked for more than one year, or have merged, cancelled, withdrawn, dissolved or expired. The content included is the same as listed above.

**Notary Public Database** – Yearly subscription fee - **\$300**

*Data is posted on the first day of the month.*

Contents: •Name of Notary • Address of Notary • Commission Date • Expiration Date

**Trademark/Service Mark Images** – Yearly subscription fee - **\$100**

*Images are posted on January 1st, April 1st, July 1st and October 1st.*

Contents: •Applications • Renewal Applications • Specimens

**UCC Data Only** – Yearly subscription fee - **\$4,800** plus initial setup\* fee of **\$1,500 = \$6,300**

\*Initial setup – **\$1,500** - Includes all recorded data contained within the UCC Information Management System as of the date of this Agreement.

Weekly - Data is posted every Sunday.

Monthly - Data is posted on the first day of the month.

**UCC Data and Images** – Yearly subscription fee - **\$8,400** plus initial setup\* fee of **\$3,000 = \$11,400**

\*Initial setup – **\$3,000** - Includes all recorded data and images contained within the UCC Information Management System as of the date of this Agreement.

Weekly - Data is posted every Sunday.

Monthly - Data is posted on the first day of the month.

*All images are posted on the first business day of each month.*
