Maintenance through Election Mailings

Election officials send mailings to voters at their residence address. If the mail is returned undeliverable by the United States Postal Service (USPS), it starts the confirmation process.

Types of mailings:

- An acknowledgment or change notice to ensure the voter lives at the address
- An official mailing, from either the State Board of Elections, local board of canvassers (BOC), or the Department of State's Elections Division, which has been sent to at least a majority of the registered voters in a particular city or town
- Notices to registered voters that have not voted or communicated with the local BOC in the past five years
- Change-of-address mailings based on the USPS National Change of Address (NCOA) database, asking a voter to confirm whether or not they have moved
- Jury notices



Initiating the confirmation process in the Central Voter Registration System (CVRS) after an undeliverable mailing

- The local board of canvassers changes the voter status in the CVRS to inactive. Inactive voters do not lose their right to vote, but must take the necessary steps to confirm their address before they are allowed to vote.
- Making a voter record inactive generates a confirmation letter, which is sent to the voter with a blank voter registration form



Steps for voters to confirm their address upon receipt of a confirmation letter

- If the voter returns the voter registration form, their status will be reactivated
- If the voter tries to vote, they will be required to complete an affirmation confirming their address
- If the voter does not update/confirm their registration, and does not vote in one of the next two federal elections, then the registration record will be canceled
